1: Purpose of Document

1.1 Introduction

The Scottish Pathology Network (SPAN) was established to support improvement of Pathology services by creating and developing a Scotland wide National Managed Diagnostic Network. This network would steer modernisation, including service change and redesign, develop benchmarking data to improve quality, and working with boards ensure provision of an effective pathology service, which anticipates and responds to user needs, future requirements, and national guidelines while meeting ISO 15189 and/or United Kingdom Accreditation Service standards.

One of the National Specialist Services Committee (NSSC) recommendations was for SPAN to produce an education strategy that considers the role of education strategies and policies of other bodies such as the Royal College of Pathologists, Institute of Biomedical Scientists (IBMS) and NHS Education for Scotland. The SPAN Education Strategy should encompass all staffing levels, including Biomedical Scientists, Healthcare Scientists, Anatomical Pathology Technologists (APTs), support staff, Doctors in Training (DiTs) and Consultant Pathologists.

1.2 Governance

This Education Strategy is designed to support the work of SPAN. It will be managed by the Network Programme Manager, and governed through the Lead Clinician, Scientific Manager and Steering Group of the Network.

Programme Manager – Camilla Young

- Manage the delivery of the Education plan.
- Develop education material as per the education plan.
- Work with the Lead Clinician to source training.
- Provide education support and advice where necessary.
- Evaluation of the Education Strategy and education plan.
- Provide updates on the Education Strategy and education plan progress to the Steering Board.

- Final approval on all educational materials.
- Taking forward specific actions assigned via the Education Strategy and education plan.

Final approval of the Education Strategy.

1.3 Why does SPAN need an Education & Training Strategy

- To address the specific educational needs out with the remit of other bodies and as required to modernise the pathology workforce.
- Improve the knowledge and skills of the Pathology community where knowledge gaps have been identified.
- To inform best practice.
- Provide the pathology community with the opportunity to learn, contribute and understand existing and new polices.
- Engagement with SPAN and the work that it is undertaking for the Pathology community and its stakeholders.
- Provide BMS with the opportunity to develop the skills and knowledge to undertake tissue dissection.
- To support or co-ordinate Nationally where there may be local board pressures to support education and training needs.
